# Setting the scene

# The 2024 Autumn Budget reduced Inheritance Tax relief on combined agricultural and business assets after the first £1 million from 100 per cent to 50 per cent from April 2026.<sup>1</sup>

The National Farmers Union (NFU) claim that 'The Budget will add to the cost of producing food at a time when hard-pressed British farmers cannot absorb it, meaning either the supply chain or consumers will end up bearing the brunt.'<sup>2</sup>

The Country Land and Business Association (CLA) said that 'capping agricultural property relief at £1 million could harm 70,000 UK farms, damaging family businesses and destabilising food security.'<sup>3</sup>
